A 50% deposit is due upon signing this contract. The deposit will be deducted from the total bill and the remaining balance must be paid, in full, on the date of the function. Check and credit card payments are accepted. Returned checks will be charged a \$25 reprocessing fee.

In the event of cancellation, we must be notified in writing 15 days prior to the date of your function. If written notice is received within that 15-day period, the deposit will be refunded and the client will receive a copy of the contract marked "cancelled." If cancellation occurs less than 15 days before the event, full prepayment will be retained. If the function is

cancelled 48 hours prior to the event, 50% of the total food and beverage cost will be charged, based on the confirmed or estimated numbers.

The final menu selections must be attached to this contract. In the event that the client would like to make a change to the menu, not due to an increase or decrease in the number of guests, we must have a 14-day notice and the change must be approved in writing. Upon signing of this contract, a guaranteed number of guests are required. If the guest count should increase or decrease by more than 5 guests, we must be notified 3 business days prior to the event. All details relating to menu selections must be confirmed one week prior to the function.

Sound Meals shall not be liable for the non-performance of this contract when such non-performance is attributed to acts of God and other causes whether enumerated herein or not, which are beyond the reasonable control, preventing or interfering with our performance. In such event, we shall not be liable to the customer for any damages, whether actual or consequential, which may result from such non-performance.

We reserve the right to make changes to your function only in the event that our quality of excellence would be compromised and client shall be notified of such changes in writing prior to the event.
